 - Savings Balance - \$59,785.49

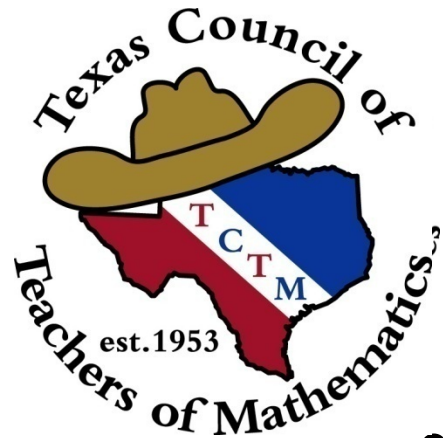
